## Prime Shopping In The Centre Of Dunstable

Dunstable is a popular market town located in central Bedfordshire, 6 miles west of Luton, 35 miles north of London. With a resident population of approximately 36,000 and a loyal shopper catchment, Dunstable has a great retail offer with a superb blend of recognised high street names through to small independent shops. The town also has an expanding leisure scene with a number of established restaurants and bars scattered throughout the town centre.

In recent years Dunstable has seen continued growth with a significant number of residential developments in the pipeline. There are approximately 10,500 new dwellings proposed within a 3 mile radius of the town centre.

## The Prime Retail Focus

Dominating the town centre and providing the prime retail focus in Dunstable, The Quadrant Shopping Centre provides **140,000 sq.ft** of purpose built retail accommodation comprising some **45 units**. The Centre is home to a number of well-known brands including **Clarks, WHSmith, New Look, Burger King and Costa Coffee.** 

Occupying a strategic position in the towns retail core, The Quadrant has high profile frontages to both the High Street (A5) and Church Street and is directly adjacent to a **76,000 sq.ft** ASDA supermarket.

The Quadrant has an integral **240 space** surface "Pay and Display" car park which also serves as one of Dunstable's main parking facilities therefore adding to the centre's strong weekly footfall.
